Subject: - Regarding getting clearance for going abroad in cases other than for training or official work.

Will the Additional Chief Secretaries and Principal Secretaries to the Government, Haryana and kindly refer to the instructions issued by this department vide U.O. No. 17/9/2005-2Pol, dated 13<sup>th</sup> September, 2005, on the subject noted above?

2 Regarding getting clearance for going abroad by officers/officials, it was decided that in cases other than for training or official work with regard to Class-III and Class-IV employees should be approved by the Head of Departments and with regard to Class-I and Class-II Officers at the level of Minister-in-Charge. However, such cases pertaining to Head of Departments, All India Services Officers, HCS Officers and Officers of the Haryana Civil Secretariat from Deputy Secretary onward should continue to be approved at the level of the Chief Minister. It is clarified that clearance in respect of all Class-II officers of the Haryana Civil Secretariat will be given by the Chief Secretary to Government, Haryana being HOD-cum-Administrative Secretary. The new delegation is summarised as under:-
