Will the Addl. Chief Secretaries/Principal Secretaries to Govt. Haryana, kindly refer to this Department's advise issued vide U. O no. **4/5/2010-2Pension** dated **25.4.2014** vide which it was advised to file review application/SLP against order dated **17.2.2014, 19.2.2014, 21.2.2014 and 5.3.2014** passed by Hon'ble High Court in various CWPs.

Now AD is advised to file a misc application for recalling order dated **17.2.2014, 19.2.2014, 21.2.2014, 5.3.2014, 21.4.2014, 15.5.2014 30.5.2014, 2.7.2014** passed in 46 CWPs (as per detail below) and modify the same because the facts and circumstances of present case **Debi Singh & others** and **R.K Aggarwal's** case were totally different. Moreover concession given by Standing Counsel is-erroneous concession and without prior approval of competent authority. Accordingly, the draft misc application prepared by Legal Cell(Finance Department) is sent herewith for taking action and similar necessary action by concerned department under intimation to Finance Department.
