
Subject:- Grant of reservation in promotion to Scheduled Caste category employees in Class III & IV posts in the services of Haryana Government/Government Undertaking and Public Sector Undertakings.

Sir/Madam,

The instructions No. 22/10/2013-IGS-III, dated 28.02.2013 were set aside, to the extent of providing for reservation in promotion to the Scheduled Caste Category employees, by the Hon'ble Punjab and Haryana High Court in CWP No. 25512 of 2012 titled Rajbir Singh Vs. State of Haryana and ors. Instructions No. 22/10/2013-IGS-III, dated 15.07.2014 which were issued in supersession of instructions No. 22/10/2013-IGS-III, dated 28.02.2013 to the extent of providing for reservation for scheduled caste category for promotion to Class III and IV posts in view of the said judgment are deemed to have been withdrawn. Now, in view of the acceptance of the report submitted by P. Raghvendra Rao Committee by the Council of Ministers in its meeting held on 30.01.2015, the Government has decided to give 20% reservation in promotion with consequential seniority to Scheduled Castes Category employees in Class-III and IV posts, with effect from 1<sup>st</sup> April, 2013. As regards roster points, the same mentioned in instructions No. 22/10/2013-IGS-III, dated 15-7-2014 for relevant category shall hold good.

The above instructions may please be brought to the notice of all concerned for strict compliance.

Sir,  
I am directed to invite your kind attention to the Government notification dated 22/10/2013-IGS-III dated 21/02/2015 and even No. dated 15/07/2014.

The above said notification dated 21/02/2015 were not able to the extent providing for reservation in promotion to the Scheduled Caste category employees by the Hon'ble Punjab & Haryana High Court in OMP No. 23512 of 2014 filed as Rajbir Singh Vs. State of Haryana & its instructions dated 13/07/2014 which were issued in continuation of its previous order dated 24/02/2013 are deemed to have been incorporated in the current provision for reservation in promotion in view of the said judgment. However, in view of the acceptance of the report submitted by P. Raghendra Rao Committee by the Council of Ministers in its meeting held on 10/01/2015, Government has now decided to give 20% reservation in promotion with consequential seniority to Scheduled Caste Category employees in Class III & IV posts w.e.f. 01/04/2015.
