Subject:- Grant of reservation in direct recruitment /admission in Universities/Colleges of Haryana State in case of Special Backward Classes.

Sir/Madam,

I am directed to invite your kind attention to the Government instructions issued vide No. 22/149/2015-1GS-III, dated 21-8-2015 vide which as an interim measure 10% seats in admissions of educational institutions were kept vacant for the time being and it was instructed that the State Government will re-visit the situation when 90% of seats are filled. Similarly suitable interim measures for cases, where recruitment process is going on or to be started shortly were also provided, which was issued in compliance of High Court order dated 27.7.2015.

2. Now the matter regarding admission in educational institutions has been re-considered and it has been decided by the State Government that for the current academic session 10% seats reserved for Special Backward Classes shall be filled up from General Category students. It has been further decided that the matter will be reviewed before next academic session, in case the pending court case is not finalized before the start of next session. As far as the reservation in employment of Special Backward Classes is concerned, there is no change in the instructions dated 21.8.2015 and backlog, if any, will be


