

Sir,

I am directed to say that the State Election Commission, Haryana has declared the Municipal General Elections to Municipal Committee, Uklana, Distt Hisar for holding the poll on 31.12.2014. Copy of Notification No.SEC/1ME/2014/1476, dated 09.12.2014 whereby the election programme has been prescribed for the conduct of general elections is enclosed. The nomination for election to the office of members in respect of Municipal Committee will start from 16/12/2014 and the nomination papers can be filed upto 20/12/2014. The date of scrutiny of nomination papers has been prescribed on 22/12/2014. The last date for withdrawal of nomination papers is 23/12/2014. The poll will be held on 31.12.2014. The counting of votes will take place on the same day.

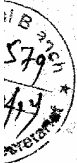
2. I am further directed to request you that officers/officials of the State Government posted in Hisar who are connected with the conduct of Municipal General Elections including middle level Revenue Officers like Tehsildar, Naib Tehsildar and Block Development Officers and officers of equivalent status in the Revenue and Land Administration Departments and Police Officers like Sub Inspectors and Assistant Sub Inspector and other equivalent Officers should not be transferred during the election period and upto the declaration of results. In such cases, where it is considered necessary to transfer any officer connected with the election to the above mentioned Municipal Committee, the approval of the State Election Commission may also be obtained. Instructions in this regard may also kindly be issued to all the departments of the State Government under intimation to the State Election Commission.

No. SEC/1ME/2014/1476 In exercise of power vested under clause (1) of the Article 243 ZA of the Constitution of India, Section 3A of the Haryana Municipal Act, 1973 and rule 19(1) the Haryana Municipal Elections Rules, 1978 and all other powers enabling it in this behalf, State Election Commission, Haryana, hereby prescribes the following election programme for the conduct of election in all wards of Municipal Committee, Uklana, Distt. Hisar :-

(1)	Date on which notice shall be published by the Returning Officer for inviting nominations under Rule 20.	10/12/2014 (Wednesday)
(2)	Dates on which Nomination papers shall be presented under Rule 19(2)(i)	16/12/2014 (Tuesday) to 20/12/2014 (Saturday) 11.00 A.M. to 03.00 P.M.
(3)	Dates on which the list of Nomination papers received shall be posted under Rule 19(2)(ii)	16/12/2014 (Tuesday) to 20/12/2014 (Saturday)
(4)	Date by which information shall be furnished by the candidate in the format prescribed, to the concerned Returning Officer that he is not suffering from any disqualification.	22/12/2014 (Monday) Before 11.00 A.M.
(5)	Date on which the nomination papers shall be scrutinized under Rule 19(2)(iii)	22/12/2014 (Monday) 11.30 A.M. onwards.
(6)	Last date for withdrawal of candidature by a candidate under Rule 19(2)(vi)	23/12/2014 (Tuesday) Between 11.00 A.M. and 3.00 P.M.
(7)	Date on which symbols shall be allotted to the contesting candidates.	23/12/2014 (Tuesday) after 3.00 PM
(8)	Date on which the list of contesting candidates shall be posted under Rule 19(2)(vii)	23/12/2014 (Tuesday)
(9)	Date on which list of polling stations shall be posted under Rule 19(2)(viii)	23/12/2014 (Tuesday)
(10)	Date on which the poll, if any, shall be held under Rule 19(2)(ix)	31/12/2014 (Wednesday)
(11)	Timing of the poll	Between 8.00 A.M. and 4.00 P.M.
(12)	Date, time and place on which the votes polled shall be counted.	Immediately after the polling is closed at all polling stations on the same day.
(13)	Date on which the election result would be declared.	Immediately after the completion of counting.

2 The Returning Officer shall publish the above election programme on 10.12.2014 by notices posted at his office, office of the Deputy Commissioner and Municipal Committee and at such other conspicuous places in the municipal area of the Municipal Committee in which the election would be held as may be determined by him in this behalf under Rule 20 of the Haryana Municipal Election Rules, 1978.

3. The State Election Commission further directs that immediately after the expiry of the period within which candidatures may be withdrawn under Rule 28 of the Haryana Municipal Elections Rules, 1978, the concerned Returning Officer shall prepare in Hindi the lists of contesting candidates, that is to say, lists of candidates who have been included in the lists of validly nominated candidates, and those who have not withdrawn their candidatures within the prescribed period. The lists shall be caused to be posted at the some conspicuous place, in the office of the Returning Officer or at the Municipal Committee office.

4. The State Election Commission further directs that the concerned Returning Officer or the Assistant Returning Officer as the case may be, shall at every stage prepare the notices of the nominations containing descriptions similar to those contained in the nomination papers both of the candidates and the proposers, the lists of candidates whose nomination papers have been rejected, the list of validly nominated candidates, the notices of withdrawal of candidatures and the lists of contesting candidates, and affix the same at some conspicuous places, at the notice board of their offices and at the office of the Municipal Committee and shall submit one copy thereof to the State Election Commission directly at every stage and one copy through the Deputy Commissioner.

5. The State Election Commission further directs that the counting of votes polled at the elections to the seat of Member of Municipal Committee shall be taken up after the close of poll at all polling stations of the Committee on the same day. The details (Accounts) of votes polled at each polling station shall be prepared in Part-II of Form 18 by the Presiding Officer and forwarded to the Returning Officer for consolidation of counting votes on Form 8 mentioning therein the total number of valid votes polled in favour of each candidates on each polling station and declare the candidate, who is found to have obtained the largest number of votes, elected as Member from the ward.

6. The State Election Commission further directs that after the declaration of result of elections under Rule 62, the Returning Officer shall forthwith post a copy of return (i.e. Form 8- Consolidation of account of the counted ballot papers) in a conspicuous place at his office and send a copy thereof to the Deputy Commissioner, who shall forward immediately but not later than three days, the name of the candidates elected to the State Election Commissioner, Haryana for notifying the same in official gazette. The Deputy Commissioner shall ensure that

the names and other particulars of the elected candidates should be the same as are recorded in the nomination paper.


