subject to the following terms & conditions:-

- a. The above appointment is subject to the decision of Hon'ble High Court in Civil Writ Petition No. 26478 of 2017 and CWP No. 18514 of 2016 (O&M) or any other case which may be pending before any Court of Law.
- b. That the candidates shall submit original certificates of their academic qualifications, age, caste/category and other relevant certificates to the concerned Head of the Office and their joining report will be accepted after verification of their documents from the issuing authorities.
- c. That they will have to appear before the Chief Medical Officer of the district where their postings are made for medical examination and should submit Medical Fitness Certificate.
- d. That if they are not found medically fit for this appointment, their appointment will be cancelled.
- e. That their joining report will be accepted after medical examination by the Chief Medical Officer.
- f. That their services will be governed by the Haryana Subordinate Agricultural (Group-C) Service Rules, 1993 or any amendment made from time to time.
- g. That their appointment is purely on temporary and provisional basis. Their confirmation against substantive posts shall be considered on the basis of their seniority and record of service only as and when such posts become available.
- h. That they shall take an oath of allegiance to India and the Constitution of India before the respective Head of the Office to whom they shall submit their joining report. A certificate on this account shall be furnished by the respective Head of the Office which will be placed in the personal files of the Agriculture Inspector (General Cadre).
- i. That they shall submit a certificate mentioning therein that they have only one living spouse, if they are married at the time of joining to the respective Head of the Office.
- j. That their seniority shall be decided in accordance with the departmental rules and instructions issued by the State Government on the subject from time to time.
- k. That they shall be kept on probation for a period of two years. The period of probation, however, can further be extended for a period not exceeding one year, if considered necessary by the competent authority.
- l. That in matters, not specifically mentioned in this communication or ibid Rules of 1993, they shall be governed by the Civil Services Rules as applicable to Haryana Government employees and/or such Rules/Orders/Instructions as may be issued by the State Government from time to time.
- m. That if at any time during the service, the appointee desires to resign, they shall be required to give one month's clear notice or forfeit the salary including allowances etc. for one month or for the period by which the notice falls short. Likewise, the Department will also be bound to give one month's notice or pay salary for the period as mentioned in this Para. In case of misconduct, however, they shall be given a reasonable opportunity to

show-cause as to why their service should not be terminated. In such a case, the condition of one month's notice will not apply.

- n. That no TA/DA will be admissible to the candidates for joining their duty at the place of their posting.
