Terms and Conditions of Appointment:-

1. That they are being appointed purely on temporary and provisional basis.
2. That their appointment is against temporary post and their confirmation against substantive posts shall be considered on the basis of their seniority and record of service as and when such post becomes available.
3. That they shall take an oath of allegiance to the Constitution of India before the respective Officer before joining.
4. They shall have to qualify the State Eligibility Test in Computer Appreciation and Application (SETC) within the period of probation of two years extendable by one year, as per provisions of Rule 9A of the Haryana Sub-ordinate Agriculture Directorate Staff (Group C) Service (Amendment) Rules, 2013, failing which your

7. That they shall be on probation for a period of two years. The period of probation can be extended further for a period not exceeding one year, if considered necessary by the competent authority.
8. That in matters, not specifically mentioned in this communication, they shall be governed by the Civil Services Rules as applicable to Haryana Government employees and such Rules / Orders/ Instructions as may be issued by the State Government from time to time. That they shall further be governed by the Haryana Agriculture Department Subordinate Offices Ministerial Staff (Group-C) Service Rules, 1994 as amended from time to time.
9. That the documents pertaining to their Educational Qualification, age, Caste/Category and Universities may please be got checked/verified from the issuing authorities, before they are allowed to join their duties.
10. That the Candidate shall submit Medical Certificate duly issued by the Chief Medical Officer, concerned.
11. That their character and antecedents have not been got verified and in case subsequently any adverse facts comes to the notice of the department regarding their character and antecedents, thier service will be terminated without any notice.
12. That those candidates who are already in Government job as Class-III or IV official, need not submit a fresh medical fitness report otherwise they shall appear before the Chief Medical Officer, concerned. They shall submit the medical fitness report in the concerned office before joining the place of their posting.
13. That if at any time during the course of their temporary appointment, any of the appointee desires to resign, he/she shall be required to give one month's clear notice or forfeit in lieu thereof, his/her salary including allowances etc. for one month or for the period by which the notice falls short of one month. Likewise, the Department will also be bound as mentioned in this para.
14. That no TA/DA will be admissible to the candidates for joining at the place of their posting.
15. That if he/she gets an appointment on the basis of his/her furnishing false/forged or fraudulent information/ facts which are detected later on to be false or forged or fraudulent, he/she would be liable for termination of service without any notice besides such criminal action that may be taken as prescribed in the Indian Penal Code or any other law for the time being in force.
16. That if they are willing to accept this offer of appointment as Clerk on the above terms and conditions, they should submit thier joining report as per directions mentioned above.
17. Their appointment is subject to the final outcome of CWP No. 14886, 16873, 19270, 23764, 23861, 23882, 23906, 24057, 24060, 24098, 24191, 24247, 24278, 24288, 24436, 24535, 27510 & 29740 of 2017 and 1252 of 2018 and any other writ petitions pending the Hon'ble High Court.
18. That the said appointment would be subject to the outcome of the proceeding pending before the Hon'ble Supreme Court in the appeal filed by the State of Gujrat.

(b) That the concerned officers shall verify that the Candidate possesses requisite qualifications and experience as per rules and that they are eligible for the post against which they are being appointed.
