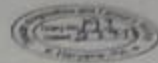

Dear Sir/Madam,

I have been directed to address you on the subject mentioned above and to inform you that Hon'ble Chief Minister, Haryana has directed that disbursement of any kind of compensation to a victim by any Haryana Government Departments/Authorities/Autonomous Bodies/Commissions under any Act/Rules/Policy/Schemes/Guidelines/Court Order/CM announcement etc. are henceforth to be made only by direct transfer through Real Time Gross Settlement (RTGS) or any other electronics method into the bank account of victim or his/her parents or his/her Legal heirs, as the case may be.

2. All the Departments are also requested to carry out any requisite statutory or administrative changes expeditiously, if required, in relevant Act/Rules/Policy/Scheme/Guidelines to implement the above directions.

3. The Departments are further requested to issue necessary instructions to their staff implementing such schemes at the district level. These instructions may be followed in true letter and spirit.
